Thank you to everyone who donated to The Hive by The Arc of Warren County through our 2023 Annual Appeal.

Keep an eye out for more information regarding our grand opening. **Anyone who donated to this initiative will receive an invitation to the event.** Funds raised through The Annual Appeal this year were earmarked for The Arc of Warren County's new Day Program location on Route 31 in Washington Township.

This gift helped fund a fully loaded sensory room, which includes multiple seating options, bubble towers, gel



floor tiles, a sensory path, fiber optic lighting, a sensory path and more. In addition, this space will be able to accommodate indoor sports activities, such as indoor basketball. "More room allows for better sounds (acoustics) to enjoy," says Burnie M., regarding music therapy activities.

Donaldson Farms Donates Toward The Annual Appeal through Corn Maze Fundraiser

Hackettstown Rotary Club and Rotary International Support Camp Warren for Essential Project

Hackettstown Rotary Club and Rotary International supported The Arc of Warren County for a much-needed project at Camp Warren recently. The need was to replace the toilets in all 16 cabins before the beginning of the summer camp season. Both organizations covered the cost of much of the project with The Arc Foundation financially supplementing a minority of the cost. Valley Plumbing, Heating, Cooling and Lawn Sprinklers, LLC was the contractor which was responsible for the installation of the toilets, which were purchased at Lowe's in Hackettstown.

The grant proposal and oversight of this project was spearheaded by Hackettstown Rotary member, Robyn Jensen, CFP[®], Financial Advisor with Edward Jones in Hackettstown. "We are extremely grateful that Hackettstown Rotary Club decided to support this project," says John Whitehead, CEO of The Arc of Warren County. "It was a needed upgrade that would have taken longer to do without the financial support. The fact that we can replace all 16 toilets, because of this grant, is extremely helpful for us as they will not need to be changed for many years."

Geraldine Urgovitch has been involved with The Arc of Warren County for many years. In June 2001, her son Robert moved to one of our residences in Hackettstown from his home near the Jersey Shore.

"My experience with The Arc of Warren County has been wonderful," says Geraldine. "I am so blessed to have him there. He is so happy and the staff is extremely caring. Robert being part of The Arc of Warren County community has made a big difference in our lives."

Robert has positive things to say about his time living in Hackettstown, especially the different activities that he is involved in. He likes going shopping in general and talks about trips to the Lehigh Valley Mall, Rockaway Mall, various creameries and farms. He especially likes his twice a week experience going to Dunkin' Donuts to get his favorite drink – a Mocha Latte.

"I also like being involved in different crafts, such as working on latch hook rugs," says Robert.

Geraldine moved to Florida a couple of years ago to be close to her son Anthony, but before she moved Robert would frequently visit for the weekends or the holidays. Geraldine was often impressed how the staff would offer to drive him halfway. It was just one more example of The Arc of Warren County staff going above and beyond in their care of residents. Geraldine also speaks fondly of the Recreation Department.

"They do such a great job at what they do," she says.

She fondly remembers how much Robert enjoyed being involved in Special Olympics in the past.

"He loved it," she says. "He doesn't do as many Recreation activities as he used to as he is turning 57 this year, but we all have fond memories of his involvement."

Jessica Chamberlin, Group Home Manager at The Arc of Warren County, loves to see the close relationship between Geraldine and Robert firsthand.

"He loves his mom so much," says Jess. "They are very interconnected even though there is a physical distance between them. They speak all the time, and he always wants his mom to be pleased with him." Robert visits his mom in Florida periodically and says he enjoys visiting with his mother.

Jess appreciates Geraldine's involvement from afar.

"She always asks about all of the staff members," says Jess. "She is very complimentary of staff and how committed everyone is."

As a result, Geraldine continues to be an active member of The Arc of Warren County. Even though she cannot attend events or visit Serendipity, she enjoys reading our Newsletter and being engaged.

"Distance cannot diminish my affinity to The Arc of Warren County," says Geraldine. "The organization and all of the people involved have been so good to myself, Robert and my entire family."

Meet Shaqwanna Lewis: Recruitment and Retention Specialist

"I make it a point to be with new employees on their first day in a group home, so they do not feel alone trying to navigate their new role. It makes it easier," says Shaqwanna Lewis, Recruitment and Retention Specialist at The Arc of Warren County. "I want our staff to know that I'm here for them."

Shaqwanna has been employed with The Arc of Warren County since 2021. She began as an Overnight Awake Direct Support Professional (DSP) and was promoted to the newly created Recruitment and Retention Specialist role in June 2023, the first of its kind for The Arc of Warren County.

For nearly a year and a half, Shaqwanna balanced two full-time jobs, working from home full-time during the day and by night at The Arc of Warren County group homes. When the Recruitment and Retention Specialist position became available, Shaqwanna was faced with a decision. She recognized that this was a position that was needed in the organization. When she was offered the role, Shaqwanna decided to let go of her career of 20 years and embark on a new journey.

"If I can make someone's day by assisting them in their day-to-day living, that is why I made the decision," Shaqwanna says. "I'm a people person and I like to see people smile."

Finding her footing in this new role has come naturally to Shaqwanna. In her words, "I see it like 'You were meant for this. This is something you were doing already on a day-to-day basis.'" Shaqwanna is often the go-to person for advice and support from her friends and family.

In her new role, Shaqwanna puts a strong emphasis on building self-confidence in every newly hired staff member. She has integrated the new Recruitment and Retention

Specialist position with the mindset of a mentor. Shaqwanna understands that starting a new job can be daunting for anyone, with or without professional experience in the field, and enjoys being a resource for new staff.

"It can be overwhelming when you are responsible for helping someone with their day-to-day living. Some people may have experience caring for family members, for example, others may not," Shaqwanna says.

Since June, Shaqwanna has welcomed many new faces into the Agency. She makes it a point to make people feel comfortable, even before they are officially hired. The opportunity to work with new hires and watch them flourish has made a great impact on her. Being a familiar face to someone beginning their career with The Arc of Warren County helps foster better communication and stronger working relationships, which leads to a higher level of care for our individuals and greater job satisfaction for staff.

"As a DSP, you need to give our consumers the best care – the same way you would give someone in your family the best care. That perspective usually clicks with them and helps new staff really understand what this job is all about."

An important part of her role at The Arc of Warren County is fostering relationships with each of the Agency's group home's consumers and staff. This helps her gain valuable insight to share with new hires about the specific program they will be working at.

"Getting to know your coworkers and

the individuals you are caring for has to come together at the same time." Shaqwanna says. "You must get to know the consumers, but we also must be on a great working level with our coworkers so we can have a better living environment for the consumers. We need to be able to communicate and come together."

In addition to serving as a mentor for new staff, Shaqwanna makes it a point to continue building relationships with longer-term staff. She wants them to know they have someone advocating for them and to know that their voice is heard. "The Arc is so much bigger than the one group home you are working in. Being involved with the Agency beyond your team is important to build positive professional relationships and discover new opportunities and experiences," Shaqwanna says. "The Arc is work, but it's good work. That's how I like it."

The Arc of Warren County has already seen Shaqwanna's impact, as staff retention rates and involvement have continued to grow over the past year.

Meet The Go-Getters: A Snapshot into What Inspires The Arc of Warren County's Self-Advocates

The Arc of Warren County's Self-Advocates, also known as Go-Getters, gather on a regular basis to achieve many goals. All the self-advocates live in one of the 17 Arc of Warren County residences. They live independently as possible and credit the help of The Arc of Warren County direct support staff to assist them with different activities, such as cooking, accompanying them to doctors' appointments, household chores, administration of medication and more.

Some weigh in at their monthly meeting regarding the types of issues that they like to discuss and their goals. See what they had to say below:

"One of my goals is making sure that we are working toward a positive future," says Arthur K.

"We discuss standing up for your rights and talking to the government," says Steve Y.

"Getting together with my friends is important to me, as well as working together," says Mary M.

Arthur, who is the President of The Arc of Warren County's Self-Advocates Chapter, explains how he is very motivated on making a difference in the community-at-large.

"I would like to work with Governors to cut down on the high prices in the United States," says Arthur. "I also like to advocate regarding all issues related to rights of people with disabilities at a higher level." Arthur also serves on The Arc of Warren County's Board of Directors.

Joe K. would like to advocate for the right to come out of retirement and go back to work even though he is in his 80s. He would like to keep busy and continue working.

Carol C. discusses how she cares more about being out in the community more than politics per se, but loves being with friends in person. She likes it a lot more than when they had to have meetings on Zoom during Covid.

Some examples of Go-Getters being out in the community include participating in the upcoming Green Music Fest, which is sponsored by the Washington BID on June 15, 2024. They will be there to talk about the

Agency and hand out merchandise.

The Go-Getters also serve as representatives for The Arc of Warren County at National Night Out in Washington. In addition, they were involved in the Love, Easton campaign in support of the City of Easton by decorating hearts around town.

The Self-Advocates will be engaged in a viewing party for the virtual conference for New Jersey Self-Advocates this spring. The Arc of Warren County Chapter was the first to engage in a conference viewing party since the conference became virtual after 2020. Now other chapters have followed suit.

Some past topics that have been covered in this conference include having the right to vote, a campaign to not use the R word and effective ways to advocate for yourself.

Other past activities include learning CPR skills from Carinne Buzzuto, The Arc of Warren County's Training Coordinator and Self-Advocates Advisor.

As Advisor for the Go-Getters, Carinne makes sure each meeting ends with a "Show and Tell" opportunity on the agenda. This is a great opportunity for every attendee to participate. They can share whatever they would like to talk about or show off something they are proud of.

The attendees appreciate the addition.

"It gets us used to public speaking," says Kristen E.

"It makes you feel more like family when you get to share," says Judy A.

Go-Getter members have showed off their artwork, crafts, photos of family and treasured gifts from their loved ones. They have talked about what is current in their lives and what they are looking forward to including vacations, work recognitions, achievements from Special Olympics and other accomplishments.

Carinne says, "I love that each member has a moment to express their confidence, pride, and joy, with all the attention on them. Each advocate deserves recognition. I am even proud when a member says, 'nothing today,' advocating their right to be private or not share." The Self-Advocates vote on which activities they would like to participate in, the terms of their officers and who their officers are. Current officers are as follows:

They have also voted on their term limits, which are four years.
