and generosity of our community. Without this support, much of what we do would be impossible.

A Word from Trailblazer and Arc Member Kerry Wolf

The Arc of Warren County member, Kerry Wolf, is no stranger to the organization.

Last year, she received The Trailblazer Award for her leadership in the early years of our grassroots organization. She has worn many hats with the organization from volunteer, to leader, to parent.

If there is ever a need to ask about The Arc of Warren County history, Kerry Wolf is the person to consult with. Her experience with The Arc of Warren County began in 1970 as a parent when it was referred to under a previous name. It was affiliated with what is now known as The Arc of New Jersey and The Arc of The United States.

"My son, Christopher, was born with Down Syndrome and back then there were not a lot of resources for parents who had children who were born with disabilities," says Kerry. "We were a very dedicated organization with parent and community members."

At that point, Camp Warren was already established, but it was not as developed as it is today.

Her advice to parents is to get involved and stay involved. This is accomplished by becoming a member of The Arc of Warren County and renewing your membership each year.

"In early days, parents had to run our own fundraisers for programs," says Kerry. "We have come a long way." Kerry also served The Arc of Warren County in a professional capacity. She was the part-time Executive Director initially, which evolved to a full-time position as the Agency developed new programs in residential services, early intervention and family support services from 1980 to 1985. At the time, her salary was made possible by funds from The United Way. She also served as Recreation Director for many years and served on the Board of Directors.

Her son, Chris, has been an employee at The Arc of Warren County for many years and all have come to love the Wolfs.

"Kerry Wolf has demonstrated such a huge commitment to The Arc of Warren County," says John Whitehead. "We are so thankful to have her as part of The Arc family."

Going For The Gold

Special Olympics New Jersey 2024 Summer Games Highlights

From the diving boards to the running track, more than a dozen athletes representing The Arc of Warren County competed in the Special Olympics New Jersey 2024 Summer Games.

Athletes begin practicing in April and compete at local and sectional competitions to advance to the annual state Summer Games through programs offered by our Recreation Department.

This summer, The Arc of Warren County's delegation included thirteen athletes, including six swimmers and seven track and field athletes, as well as eight coaches and chaperone personnel. The Games were hosted at The College of New Jersey in Ewing, NJ on Friday, June 7 through Sunday, June 9.

On Friday, almost 2,000 Special Olympics New Jersey athletes, along with thousands of spectators and volunteers, gathered for the Opening Ceremony.

The months of training, hard work and determination paid off for our athletes competing in this year's Summer Games. The Arc of Warren County athletes competed in over 25 events and received 12 gold medals, 4 silver medals and 3 Bronze medals!

Our track and field athletes did well and had a great time competing in a variety of Athletic Events including



throwing, running, and walking competitions.

Athletes won the Gold Medal in their respective divisions for the Women's 100M Dash, Men and Women's 100M Walk, Women's 200M walk, and Women's 400M walk. The Arc of Warren County team took home a total of 6 Gold medals, 3 Silver medals, and 1 Bronze medal.

The Warren Stingrays swim team competed in the 25M Freestyle, 50M Freestyle, 4x25M Freestyle Relay and 4x25M Medley Relay.

Our Relay Team took home the Gold in their division for the 4x25M Freestyle Relay with a final time of 01:18.58 and Bronze in their division for the 4x25M Medley Relay with a final time of 01:53.18! In all, the Warren Stingrays took home 6 Gold, 1 Silver and 2 Bronze medals. The Warren Stingrays performed exceptionally well all season, in large part thanks to the guidance of Coach James Dailey and the Lafayette College Swim Team.

This partnership has continued for nearly three decades!

Coach Jim Dailey of Lafayette College and the Lafayette College Swim Team will be recognized for their volunteer service in November at The Arc of Warren County 70th Anniversary Gala.
